



COOPERATION PROTOCOL BETWEEN SAKARYA UNIVERSITY AND ODESSA NATIONAL MARITIME UNIVERSITY

AIM

ARTICLE 1 - In order to promote and extend mutual cooperation and understanding, Sakarya University and Odessa National Maritime University agree to establish scientific and educational cooperation.

PARTIES

ARTICLE 2 - The parties to the protocol are Sakarya University and Odessa National Maritime University

SCOPE

ARTICLE 3 - The parties agree to cooperate on joint scientific, educational and administrative studies at both universities.

ARTICLE 4 - The parties agree to provide for the exchange of students, teaching staff members, administrative staff members and researchers.

ARTICLE 5 - Applications for exchanges submitted by the above mentioned students, teaching staff members, administrative staff members and researchers will be evaluated by the host institution according to the facilities available.

ARTICLE 6 - The parties agree to engage in mutual knowledge-sharing, and to provide for the exchange of scientific publications for educational and research purposes.

ARTICLE 7 - The parties agree to organize joint scientific activities (seminars, symposiums, congresses, conferences etc.) on condition that mutual agreement can be reached.

ARTICLE 8 - The parties agree to invite teaching staff members of the other university to scientific conferences which they organize.

ARTICLE 9 - The parties agree to cooperate on cultural activities.

ARTICLE 10 - This protocol has no financial obligations. This protocol shall not cause any binding financial obligation for either party.

ARTICLE 11 - The coordinator responsible for administering the terms of this protocol for Sakarya University shall be the Coordinator of the International Relations Office.

The coordinator responsible for administering the terms of this protocol for Odessa National Maritime University shall be Dean of Foreign Students Faculty.

Any change in the designated coordinator for one party shall be communicated in writing to the coordinator of the other party within 30 days of any such change being made.

DURATION



COOPERATION PROTOCOL BETWEEN SAKARYA UNIVERSITY AND ODESSA NATIONAL MARITIME UNIVERSITY

ARTICLE 12- This protocol will become valid when it has been signed by the legal representatives of both parties, and it will be valid for a period of 5 (five) years. The protocol may be extended further if mutual agreement is reached by written consent.

VALIDITY



ARTICLE 13 - The protocol, and any supplements to the protocol will become valid when they have been signed by the legal representatives of both parties.

ARTICLE 14 - Either party may terminate the protocol by presenting written notice to the other party 6 (six) months prior to termination. In the case of termination of the protocol, all on-going activities shall be completed.

ARTICLE 15 - The parties agree that the protocol is prepared in Turkish and English languages as four original copies, and it will become valid when all copies have been signed by the authorized legal representatives of both parties.

EXECUTION

ARTICLE 16 - This protocol is administered by the Rector of Sakarya University and the Rector of Odessa National Maritime University.
